

Disclosure on Liquidity Risk as on 30-Sep-2024

RBI has issued guidelines on Liquidity Risk Management Framework for Non-Banking Financial Companies including Housing Finance Companies. As per the guidelines, the disclosure on liquidity risk as at Sep 30, 2024 is as under:
